

The seat of the Arbitration shall be in Sohar, Sultanate of Oman. The language to be used in the Arbitration proceeding shall be English. The award of the Arbitrator shall be final, binding and conclusive on the **parties hereto**.

Limitation of Liability to the maximum extent permitted by law: (i) seller's total liability under the order for any goods will be limited to the amounts paid to the seller under the contract for those goods; and (ii) neither party will be liable to the other for any lost income, lost business or opportunity, loss of use or production, loss of data, claims of the purchaser's customers or other contractors or any consequential, indirect or special damages of any kind. These limitations apply notwithstanding any provision to the contrary in the order and are intended to survive in all circumstances.

**Assignment**: Neither Party may assign, transfer or create any trust in respect of, or purport to assign, transfer or create any trust in respect of, any of its rights or obligations under this Contract without having first obtained the other Party's written consent, not be unreasonably withheld or delayed.

**Governing Law:** This contract of sale & purchase is construed and shall be governed in accordance with the laws of OMAN without giving effect to any principle of conflict of law.

#### **Termination:**

- 1. Either Party breaches any of its material obligations under this contract of sale & purchase;
- 2.If either Party: (i) becomes insolvent; (ii) is unable to pay its debts as they fall due; (iii) applies for, consents to or suffers the appointment of a liquidator or receiver in respect of the whole or any part of its undertaking, property, assets or revenues; (iv) takes any proceedings under any law for a readjustment or deferment of any of its obligations under this Contract; (v) makes or enters into a general assignment or



any arrangement or composition with or for the benefit of its creditors; (vi) suspends or threatens to suspend payments on any of its debts; or (vii) ceases or threatens to cease to carry on its business; or

- 3. any governmental or other license, approval, authorization, consent or exemption that is required to enable a Party to perform any of its obligations under this Contract is withdrawn or modified (and in the case of a modification, the modification has a material impact on the ability of that Party to perform its obligations under this Contract
- 4. the other Party may issue a Notice to the affected Party of its intention to terminate this Contract. Such termination notice shall identify the relevant termination event and shall specify a cure period of 30 Business Days; after which, if the termination event is continuing, either Party may issue a Notice to the other Party immediately terminating the Contract.
- 5. Each Party's further rights and obligations cease immediately on termination of this Contract, but termination does not affect either Party's accrued rights and obligations at the date of termination.

Jurisdiction: The Court in OMAN shall have exclusive jurisdiction on any of the terms touching upon any subject matter of this contract of sale & purchase.

MJUNCTION SERVICES LTD, a company incorporated and registered in India and having its registered office at Godrej Waterside, 3rd Floor, Tower 1, Plot V Block DP, Sector V, Salt Lake, Kolkata - 700091. India (hereinafter referred as "Service Provider").

The General Rules and Regulations provided herein govern the conduct of on-line forward E-Auctions arranged by "Service Provider" on its E-Auction Platform. These rules cover the roles and responsibilities of the Parties in the online Forward E-Auctions on the E-Auction Platform. The acceptance, in-toto, to these General Rules and Regulations governing conduct of Online E-Auctions, and Terms and Conditions for sale of Materials belonging to Jindal Shadeed Iron & Steel LLC, Oman by Online E-Auction is a pre—requisite for securing participation of each Bidder in the Online E-Auctions.

The key terms pertaining to the online Forward E-Auctions are provided below. Prospective bidders are advised to read the same.

Role Of "Service- Provider"



- 1. "Service Provider' is the agency (operator) primarily providing the service of the Forward e-Auction to the "Client".
- 2. Finalization of the e-Auction items in consultation with the Client.
- 3. Defining of bidding rules for each e-Auction in consultation with the client.
- 4. Enhancing bidder awareness of and comfort with the e-Auction mechanism and bidding rules.
- 5. Input of the E-Auction items and defining the bidding rule in the e-Auction engine.
- 6. Enlarging the bidder base by introducing new bidders.
- 7. Facilitating the collection of EMD deposit receipts and informing Jindal Shadeed Iron & Steel LLC, Oman Letter of Interest if any etc. from the willing bidders
- 8. Providing access to the approved bidders to participate in the E-Auction.
- 9. Summarizing the E-Auction proceedings and communicate the outcome to the Client.

The responsibility of fulfillment of the contract rests between the bidders and the client and the responsibility of the "Service Provider" shall be restricted to the extent of the Services provided by them.

#### **Role Of Bidder:**

The role of the Bidder is outlined below:

- 1) The Bidder would participate in the e-Auction with the aim of bidding to secure the e-Auctioned item in the Online E-Auction.
- 2) The Bidder would be provided access to the Online E-Auction through a "User ID" protected by a "Password". - 3) Bidders hereby confirm that they shall commit to lift the item (being bid for) at the price entered by them in the e-Auction engine AND at the terms and conditions specified herein by the Client. #### **Bidding Rules:**

- Start Time and duration of the e-Auction.
- Any extension of the duration of the e-Auction in the event of bids being received towards the end of the pre-specified duration.
- Start Bid Price.
- Specified Unit for Bidding.
- Price Increments and any reduction in the price increment in the e-Auction in the event of inactivity.
- Other attributes (informational/non-negotiable in nature).

#### **Conduct Of The eAuction:**

Only those Bidders who have been approved by the "Client" and handed over stamped and manually signed "General Rules and Regulations governing conduct of Online E-Auction along with Letter of Interest, required EMD amount and other necessary documents to the "Service Provider" prior to the start of Online E-Auction will be given "Login ID" and "PASSWORD" to enable them view and participate in Online E-Auction. "Jindal Shadeed Iron & Steel LLC, Oman" will have the sole discretion to approve the Bidders who have submitted bids and no requests will be entertained in this regard by Service Provider from the Bidders.

"Service Provider" shall not be liable to the Client/ Bidders participating in the Online E-Auction or any other person(s) for:

- Any breach of contract between winning Bidder and Client.
- Any delays in initiating the online e-Auction or postponement / cancellation of the online e-Auction proceedings due to any problem with the hardware / software / infrastructure facilities or any other shortcomings.

While, reasonable care and diligence will be taken by "Service Provider" in discharge of its responsibilities such as design of the online bid, communication of bid details and rules, guidance to client/ bidders in accessing the E-Auction Engine and placing bids, etc. the bidders shall specifically indemnify "Service Provider" from all liabilities for any shortcomings on these aspects. It is clearly understood that these activities are undertaken by "Service Provider" to assist the Bidders in participation but the ultimate responsibility on all these counts lies totally with the bidders.

#### **Right Of The Client:**

The Client reserves the right to partially or totally accept or reject any / all bids placed in the Online E-Auction without assigning any reason whatsoever. The decision of the Client would be final and binding on the Service Provider and the Bidder in any such case. In case the Online E-Auction is cancelled by Client, then Service Provider shall undertake the re-e-Auction at its own cost, as directed by the Client.

#### **Confidentiality Clause:**

"Service Provider" undertakes to handle any sensitive information provided by the Client or confirmed Bidders for the e-Auctions conducted with utmost trust and confidentiality.

# **Definition of Key Terms**

#### eAuction:

eAuction refers to a forum where the requirement for one/more lots of an item is stated and the participants (bidders) are required to bid down the price to be selected to supply the requirement.

#### Online eAuctions:

Online e-Auctions refer to those e-Auctions conducted through the Internet with the bidders (from one or more locations) simultaneously bidding to be selected for supplying the item/s on E-Auction. In other words, the venue for the e-Auction is on an Internet website/ platform.

Services refer to the Online E-Auctions conducted by the Service Provider through its website as the venue for the purpose of the Online E-Auction and also includes the responsibilities narrated under the head "ROLE OF SERVICE PROVIDER" above.

#### Award at the eAuction:

In a single winner format, only one bidder (normally the bidder who quotes the highest price) is awarded all the units of the item being e-Auctioned. The bidder quoting the highest price is normally allotted the item.

#### Client

Client is the individual/business entity who has contracted "Service Provider" to conduct such e-Auction. In case of e-Auction, the purpose would be the genuine intent to sell the selected item/s (Lot) to the bidders desiring to buy these items from the Client.

#### Bidder:

Bidder is the individual/business entity participating in the e-Auction,

Intending to buy the item(s) from the Client. To be become a Bidder in the e-Auction, a business entity has to secure client approval for participation and also provide written assent to the General Rules and Regulations.



#### **eAuction Engine:**

E-Auction Engine refers to the software that encapsulates the entire e-Auction environment, processing logic and information flows. "Service Provider" is the sole owner of the e-Auction engine and retains exclusive right over the utilization of the same.

#### **Timings of the Online Bid:**

All the timings of the Online Bid shall be based on the time indicated by the Server hosting the E-Auction Engine. It shall be the endeavor of "Service Provider" to ensure that the Server Time reflects as closely as possible the Indian Standard Time (IST) i.e. GMT + 0530 hrs. However, in the event of any deviations between the Server Time and the Indian Standard Time, the functioning of the E-Auction Engine (Launch, operation, and closure) would be guided by the Server Time.

Bidders are advised to refresh both the windows of the E-Auction Module check the exact Server Time (displayed in both the windows).

#### **Preview Time:**

Preview Time refers to the period of time that is provided prior to the commencement of bidding. This is to facilitate approved participants to view the e-Auction details such as item specifications, bidding details and bidding rules. The purpose is also to familiarize participants with the functionality and screens of the e-Auction mechanism. It is not mandatory for "Service Provider" to provide Preview Time.

#### **Start Time:**

Start time refers to the time of commencement of the conduct of the online e-Auction. It signals the commencement of the Price Discovery process through competitive bidding.

#### **Duration of the eAuction:**

It refers to the length of time the price discovery process is allowed to continue by accepting bids from competing bidders. The duration of the e-Auction would normally be for a pre-specified period of time. However, the bidding rules may state the conditions when the pre-specified duration may be curtailed/extended. The conditions include:

- Curtailment of e-Auction duration in the event of no bids for a specified period of time (Inactivity Time)
- Automatic extension in the event of bids being entered towards the end of the scheduled duration to facilitate the other bidders to view and react to the bid.

#### **Auto Extension of the eAuction Timings:**

In the event of bids in the last few minutes of the scheduled bid time, the Bid Timings are automatically extended for a specified period from each such bid. Such Auto Extension shall continue until no bids are placed for the specified period (Engine remains inactive for the specified period). The Inactivity Time for Auto Extension purpose is normally X minutes. "Service Provider" however retains the right to change the same. The Inactivity Time applicable for the particular Online Bid shall be visible to the bidders under the Bidding Rules module on the engine.

Auto Extension of Bid:-



In the event of bids in the last 3 minutes of the scheduled bid time, the Bid Timings are automatically extended for a specified period from each such bid so that at least 3 minutes are there to each bidders to react & put their bid. However Mjunction retains the right to change the same.

#### End of the eAuction:

End of the E-Auction refers to the termination of the e-Auction proceedings signaling an end to the price discovery process.

#### **eAuction Report:**

"Service Provider" would provide an E-Auction Report to the Client containing a summary of the e-Auction proceedings and outcome. The E-Auction Report would constitute the official communication from "Service Provider" to the client about the outcome of the E-Auction.

#### Please Note: -

- It is understood by the *Buyer* that while identifying the scraps, counting, loading and delivery throughout, representatives from Security and Factory will be monitoring the entire activity to ensure that items loaded onto the *Buyer*'s vehicle are strictly as per the above items in their specific category.
- The *Buyer*, prior to giving quotation to the *Seller*, has already seen, inspected and is satisfied about the condition in which the scrap is lying in the *Seller*'s premises and *Seller* will not entertain any return or rejection of the inspected and delivered scrap materials.
- The *Buyer* hereby agrees to clear the scrap on requirement basis from the premises of the *Seller* as required.

- No complaints regarding the difference in material quality or quantity will be entertained
- Materials offered would be under "as is where is" basis and "no complaint basis". Any Picking, sorting, cutting, cleaning or breaking up of scrap materials will not be permitted.
- Successful Bidders has to make his own arrangements for shifting, loading, unloading & transportation of scrap items at their own cost.
- Loading and weighing of the goods at designated weighing machine have to be executed in the presence of Jindal Shadeed Iron & Steel LLC, Oman authorized representatives.



- The authorized personnel of the successful bidder visiting the warehouse for lifting the goods should necessarily carry valid authorization letter and the proper photo identity as per the requirement of Jindal Shadeed Iron & Steel LLC, Oman.

# **Note on Auction Logic**

#### Dynamic Rank Based Seal Bid (Sealed bid with real-time ranking)

- Auction will be conducted with sealed bid methodology. In this method, the H1 price will not be visible to any participating bidders.
- 4 The bidders will only be able to see their own placed bid value.
- The bidders will also be shown the rank of their bid against all other competing bids in the particular lot. The bidders need to improve their bids to become Rank-1 in a particular lot.
- There will be no start price i.e. bidders can start bidding at any price they wish to. They may revise their bid multiple times during the run time of the auction. However, such revisions need to be more than their last placed bid.
- The scheduled remaining time is shown in the bidding screen. This screen auto-refreshes in every 15 seconds.
- In case a bid comes within 3 minutes of scheduled closing time, the remaining closing time will be reset to 3 minutes.



Auction will close only when no further bids from any participating bidders are placed within scheduled close time.
