Qualification Requirement

All bidders approved by NLC India Ltd and registered with mjunction services limited.

Pre-Bid EMD Deposit

All buyers registered with mjunction services limited shall deposit a **non-interest bearing EMD** only in favour of 'mjunction services limited' at the rate of Rs. 25/- PMT (*minimum 100 MT and multiples of 25 MT thereafter*). ^{*}All the customers will have a unique account number. The unique account number is an alphanumeric code consisting of 13 characters. The Customer's unique "account number" is a combination of the MJ' SAP code along with the 7 digit Bidder/s SAP ID and can be used as reference for all subsequent transactions. The Customer's Account Number detail is available in "Profile" after the customer logs into our website using the user id and password.

Pre-Bid EMD of the successful bidders

The equivalent amount of EMD of successful bidder corresponding to successful bid quantity, shall be blocked and will be transferred to NLCIL by mjunction. It will be converted into Security Deposit and will be retained by NLCIL till the successful completion of the contract.

Refund of Pre-Bid EMD of the successful bidders

EMD of the unsuccessful bidders will be released to the respective free-pool account after the closure of e-Auction. It will be refunded to the bidder by mjunction on receipt of online refund application from the bidder after the closure of e-Auction. However, if no such request is received mjunction will retain the EMD for participation in e-Auction in future.

Security Deposit

There will be no additional charges as Security Deposit. However, EMD amount shall not be treated as an adjustment towards the Fly Ash value but would stand converted into a 'Security Deposit' for performance of the bidders towards completion of the said transaction.



Material Value Payment & Lifting Terms

The successful bidders of e-auction will be required to deposit total Fly Ash value with all prevailing applicable taxes to NLCIL, within a period of 7 (seven) NLCIL working days, after the date of closing of e-Auction.

The Fly Ash value can be deposited by way of demand draft/pay order, drawn in favour of M/s. NLC India Limited, along with the debit advice issued by the bank, certifying that the DD/pay order has been issued, by debiting the account of the concerned Buyer.

Participation Terms

- Registration with mjunction services limited and subject to approval by NLCIL.
- ≠ Eligibility declaration by NLCIL. The customers need to be eligible as per the qualification requirement of NLCIL for participation in Fly Ash auction.
- Pre-Bid EMD submission to mjunction services limited
- Self-Attachment with the auction

It is the responsibility of the buyer to submit all the required documents to mjunction services limited for registration and the required documents regarding fly ash procurement from NLCIL. For all new customers, the log in credential will be issued to only on completion of registration.



Penalty Terms

Forfeiture of EMD paid to NLCIL if a buyer fails to fulfil his contractual obligation.

Conditions mentioned in Terms & Conditions will also apply.

If a successful bidder fails to lift the goods as per the payment & lifting schedule from the date of issue of sale confirmation, NLCIL may at its discretion allocate the remaining quantity to any other bidder.

Besides, NLCIL reserves the sole right and discretion of disposing off such goods to any other bidder and the penal action as per the scope may be taken against the defaulting customer.

Debar Clause

In case of any default by the customer in payment or lifting or in any terms & condition of the auction, the customer may be debarred from participating in future auctions as per the discretion of NLCIL and mjunction services limited.

Extension in Payment & Material Collection

Extension in Payment & Lifting Time: An extension may be allowed at the discretion of the concerned authorities of the client under extra-ordinary conditions. The Winning customers wanting to avail the same will have to take prior approval from the concerned authorities of NLCIL. However, this shall purely be at the discretion of NLCIL.

Few Terms to Note

Customers must be extremely careful to avoid any wrong bidding (whether typographical or otherwise). They must check and rectify their bid (if required) before submitting their bid in the live e-auction floor by clicking bid submission button.

The customers shall be solely responsible for all consequences arising out of the bid submitted by him (including any wrongful bid submitted by him) customers must always ensure to keep their e-mail address valid and alive. It is the responsibility of the customer to verify the status of their bids and check their e-mails to be intimated for all further proceedings in terms of these presents.



Each lot put up for auction shall be deemed to be a separate contract of sale.

Arbitration Clause: Dispute or differences arising out or relating to this Agreement shall be resolved through amicable mutual discussion. Failing such amicable resolution of dispute / differences either of the party may refer the matter to arbitration of a Sole Arbitrator to be appointed by the Managing Director of mjunction services limited (for issues relating to mjunction) or by "NLCIL" (for issues pertaining to NLCIL). The award of the Arbitrator shall be final, binding and conclusive on the parties hereto. The venue for arbitration shall be Chennai, Tamil Nadu. The Arbitration proceedings will be governed and regulated by the provisions of Indian Arbitration and Conciliation Act, 1996 and the rules framed there under from time to time.

Governing Law: This Agreement is construed and shall be governed in accordance with the laws of India without giving effect to any principle of conflict of law.

Jurisdiction: The Court at Tamil Nadu shall have exclusive jurisdiction on any of the terms touching upon any subject matter of this agreement.

GENERAL RULES AND REGULATION GOVERNING CONDUCT OF ONLINE AUCTIONS ON THE "SERVICE PROVIDER" PLATFORM

INTRODUCTION:

This Online Auction is being conducted for

NLCIL having its registered office at "Barsingsar House, 135, Periyar E.V.R. Periyar Road, Chennai 600010" (Hereinafter referred to as the "Client") on the Auction Platform of

MJUNCTION SERVICES LTD, a company incorporated and registered in India and having its registered office at Godrej Waterside, 3rd Floor, Tower 1, Plot V Block DP, Sector V, Salt Lake, Kolkata - 700091, WB, India (hereinafter referred as "Service Provider").

The General Rules and Regulations provided herein govern the conduct of online Auctions arranged by "Service Provider" on its Auction Platform. These rules cover the roles and responsibilities of the Parties in the online Auctions on the Auction Platform. The acceptance, intoto, to these General Rules and Regulations governing conduct of Online Auctions, and Terms and Conditions for sale of Materials belonging to NLCIL by Online Auction is a pre—requisite for securing participation of each Customer in the Online Auctions.

The key terms pertaining to the online Auctions are provided in the "Annexure-D". Prospective customers are advised to read through the same.



ROLE OF "SERVICE- PROVIDER"

- "Service Provider' is the agency (operator) primarily providing the service of the auction to the "Client".
- Finalization of the auction items in consultation with the Client.
- **♣** Defining of bidding rules for each auction in consultation with the client.
- Enhancing customer awareness of and comfort with the auction mechanism and bidding rules.
- Input of the Auction items and defining the bidding rule in the auction engine.
- ♣ Enlarging the customer base by introducing new customers.
- Collection of Earnest Money Deposit (EMD), Letter of Interest etc. from the willing customers (if any as per the auction terms & conditions)
- ♣ Providing access to the approved customers to participate in the Auction.
- ♣ Summarizing the Auction proceedings and communicate the outcome to the Client.

The responsibility of fulfilment of the contract rests between the customers and the client and the responsibility of the "Service Provider" shall be restricted to the extent of the Services provided by them.

ROLE OF CUSTOMER

The role of the Customer is outlined below:

- ♣ The Customer would participate in the auction with the aim of bidding to secure the auctioned item in the Online Auction.
- The Customer would be provided access to the Online Auction through a "User ID" protected by a "Password". The Customer needs to ensure that the "User ID" and "Password" is not revealed to unauthorized persons. Customers are also requested to change the Password allocated to them by the "Service Provider" to keep their confidentiality. However, it would be Customer's sole responsibility to ensure the security and privacy of the same and he/they would not hold the "Client" / "Service Provider" responsible in any manner whatsoever for any misuse of these user IDs and/or Password. The access to the auction mechanism shall be provided to all the approved Customers subsequent to obtaining their written consent to the General Rules & Regulations and



the Letter of Interest. The payment of Pre-Bid Deposit as decided by the Service Provider before the start of the Online Auction will be one of the necessary conditions for participating in the auction.

- ♣ Customers hereby confirm that they shall commit to lift the item (being bid for) at the price entered by them in the auction engine AND at the terms and conditions specified herein by the Client. All prices entered shall be legally binding on the Customers. Customers are strongly advised to exercise due diligence while placing bids. Failure to honour the bids placed during online bidding shall render the Customers liable for penal action as deemed fit by "Client" / "Service Provider".
- ♣ In the event of winning an allotment in the auction mechanism, the Customer shall commit to fulfil outlined obligations under the contract between Winning Customer and Client.

The Customers shall bid on the terms & place their bid in the auction engine in the manner specified herein. The Customers shall not stipulate any conditions on their own unless the terms herein expressly permit such conditions being stipulated by the Customer. Bids entered with conditions attached shall be considered Conditional bids & "Service Provider" retains the right of rejecting these bids even without intimating the Client.

BIDDING RULES

The Bidding Rules refer to the information and terms defined specifically for a particular auction. The purpose of the Bidding rules is to provide approved customers with the information and terms specific to the auction in which they are bidding. This would include:

- Definition of the unit bidding.
- Start Time and duration of the auction.
- ♣ Any extension of the duration of the auction in the event of bids being received towards the end of the pre-specified duration.
- Start Bid Price.
- Specified Unit for Bidding.
- Price Increments and any reduction in the price increment in the auction in the event of inactivity.
- Other attributes (informational/non-negotiable in nature).

While it shall be the endeavour of "Service Provider" to specify these rules at the earliest for each Online Auction. The "Service Provider" only in the case of unforeseen contingency beyond its control shall retain the right to delay the announcement of these biddings rules or modify rules



specified earlier at the time of the online bidding in prior written consent of the Client. These details would be available to the customers on the Auction Engine at the time of bidding.

The participation in the auction process presumes complete awareness and understanding of the bidding rules.

CONDUCT OF THE AUCTION:

Only those Customers who have been approved by the "Client" will be given access to enable them view and participate in Online Auction. 'NLCIL' will have the sole discretion to approve the Customers who have submitted bids and no requests will be entertained in this regard by Service Provider from the Customers.

The Online Auction shall be conducted on pre-specified date. The Key Terms pertaining to the conduct of Online Auction such as "START TIME", "DURATION", "END TIME" AND "AUTO EXTENSION FACILITY" Shall be specified separately for each Auction.

"Service Provider" retains the right to cancel or reschedule the Online Auction, with the prior written approval of the Client.

The duration of Online Auction may also vary from the pre-specified period of time on account of termination of the Online Auction by "Service Provider" on the advice of the Client.

OR

In case of situations where it is felt that continuance of the auction proceedings is prejudicial to the smooth conduct and / or the integrity of the auction process.

OR due to Auto Extension during the Auction, duration may increase from specified period.

In the event of any problems being faced in the smooth conduct of the Online Auction, "Service Provider" with the approval of the Competent Authority of the Client, shall have the right to undertake one or more of the following steps:

- **♣** Cancellation/ premature termination of the Online Auction with/ without a subsequent rerun of the auction on a mutually decided date.
- Cancellation of a bid
- Locking / deactivate a customer's account (suspension of operations in the account), etc.

In case of failure of internet connection, Customer will communicate his best price to the "Service Provider" and "Service Provider" will bid on behalf of the Customer with the minimum increment until the bid price reaches the best price offered by the Customer, by proxy bidding mechanism.

The best price communicated by the Customer will have to be authenticated by written confirmation or fax to the "Service Provider" and will be kept confidential between the "Service Provider" and the Customer. Customer will be bound by the price offered.



LIABILITY OF "SERVICE PROVIDER"

"Service Provider" shall not be liable to the Client/ Customers participating in the Online Auction or any other person(s) for:

- 4 Any breach of contract between winning Customer and Client.
- ♣ Any delays in initiating the online auction or postponement / cancellation of the online auction proceedings due to any problem with the hardware / software / infrastructure facilities or any other shortcomings.

While, reasonable care and diligence will be taken by "Service Provider" in discharge of its responsibilities such as design of the online bid, communication of bid details and rules, guidance to client/ customers in accessing the Auction Engine and placing bids, etc. the customers shall specifically indemnify "Service Provider" from all liabilities for any shortcomings on these aspects. It is clearly understood that these activities are undertaken by "Service Provider" to assist the Customers in participation but the ultimate responsibility on all these counts lies totally with the customers.

RIGHT OF THE CLIENT:

The Client reserves the right to partially or totally accept or reject any / all bids placed in the Online Auction without assigning any reason whatsoever. The decision of the Client would be final and binding on the Service Provider and the Customer in any such case. In case the Online Auction is cancelled by Client, then Service Provider shall undertake the re-auction at its own cost, as directed by the Client.

CONFIDENTIALITY CLAUSE:

"Service Provider" undertakes to handle any sensitive information provided by the Client or confirmed Customers for the auctions conducted with utmost trust and confidentiality.

JURISDICTION

Any disputes relating to the online auction module shall be subject to the sole jurisdiction of Court of Law having jurisdictions over the Plant from where the Materials are being sold.

Annexure - D

Definition of Key Terms



Auction

Auction refers to a forum where the requirement for one/more lots of an item is stated and the participants (customers) are required to bid down the price to be selected to supply the requirement.

Online Auctions

Online auctions refer to those auctions conducted through the Internet with the customers (from one or more locations) simultaneously bidding to be selected for supplying the item/s on Auction. In other words, the venue for the auction is on an Internet website/ platform.

Services refer to the Online Auctions conducted by the Service Provider through its website as the venue for the purpose of the Online Auction and also includes the responsibilities narrated under the head "ROLE OF SERVICE PROVIDER" above.

Auction Type

Forward Auction Only - Price-Quantity-Time Logic

Bid Value

Bidders are to quote rate and quantity for the entire duration of the contract.

Quantity Capping

A bidder is allowed to bid for minimum 100 MT and maximum for the auction quantity, subject to the eligibility and availability of Pre-Bid EMD. Quantity capping restrictions as prescribed by NLCIL will prevail on the bidders.

Start Bid Price

Minimum bid price to start bidding.

Minimum Bid Price Increment

Minimum value by which a price bid must be increased.

Minimum Bid Price Quantity Increment

Minimum quantity by which a quantity bid must be increased.

Minimum run time

Minimum time that auction shall be open for bidding.

Time Left

Time remaining for scheduled closure of bidding.



Auto extension

Bids received within a certain duration of closing time will increase the time left to a certain extent from the last bid time.

Lead Price

Prevailing highest price in the auction

My Last Bid

Last quoted rate by the bidder

Bid Status

Bids are either accepted or rejected. The rejection reasons are displayed on the screen

Quantity Allocation

Displays quantity allocation to the respective bidders during auction run-time. This field is dynamic and changes from time to time during the auction run-time basis the valid bids received in the system and the available free quantity.

Award at the Auction

In a single winner format, only one customer (normally the customer who quotes the highest price) is awarded all the units of the item being auctioned or for the quantity placed by the bidder subject to availability of EMD. The customer quoting the highest price is normally allotted the item.

Client

Client is the individual/business entity who has contracted "Service Provider" to conduct such auction. In case of auction, the purpose would be the genuine intent to sell the selected item/s (Lot) to the customers desiring to buy these items from the Client.

Customer

Customer is the individual/business entity participating in the auction, Intending to buy the item(s) from the Client. To become a customer in the auction, a business entity has to secure client approval for participation.

Auction Engine

Auction Engine refers to the software that encapsulates the entire auction environment, processing logic and information flows. "Service Provider" is the sole owner of the auction engine and retains exclusive right over the utilization of the same.



Timings of the Online Bid

All the timings of the Online Bid shall be based on the time indicated by the Server hosting the Auction Engine. It shall be the endeavor of "Service Provider" to ensure that the Server Time reflects as closely as possible to the Indian Standard Time (IST) i.e. GMT + 0530 hrs. However, in the event of any deviations between the Server Time and the Indian Standard Time, the functioning of the Auction Engine (Launch, operation, and closure) would be guided by the Server Time. Customers are advised to refresh both the windows of the Auction Module check the exact Server Time (displayed in both the windows).

Preview Time

Preview Time refers to the period of time that is provided prior to the commencement of bidding. This is to facilitate approved participants to view the auction details such as item specifications, bidding details and bidding rules. The purpose is also to familiarize participants with the functionality and screens of the auction mechanism. It is not mandatory for "Service Provider" to provide Preview Time.

Start Time

Start time refers to the time of commencement of the conduct of the online auction. It signals the commencement of the Price Discovery process through competitive bidding.

Duration of the Auction

It refers to the length of time the price discovery process is allowed to continue by accepting bids from competing customers. The duration of the auction would normally be for a pre-specified period of time. However, the bidding rules may state the conditions when the pre-specified duration may be curtailed/extended. The conditions include:

- Curtailment of auction duration in the event of no bids for a specified period of time (Inactivity Time)
- 4 Automatic extension in the event of bids being entered towards the end of the scheduled duration to facilitate the other customers to view and react to the bid.

Auto Extension of the Auction Timings

In the event of bids in the last few minutes of the scheduled bid time, the Bid Timings are automatically extended for a specified period from each such bid. Such Auto Extension shall continue until no bids are placed for the specified period (Engine remains inactive for the specified period). The Inactivity Time for Auto Extension purpose is normally X minutes. "Service Provider" however retains the right to change the same. The Inactivity Time applicable for the



particular Online Bid shall be visible to the customers under the Bidding Rules module on the engine.

Auto Extension of Bid

In the event of bids in the last 5 minutes of the scheduled bid time, the Bid Timings are automatically extended for a specified period from each such bid so that at least 5 minutes are there to each bidders to react & put their bid. However, mjunction retains the right to change the same.

End of the Auction

End of the Auction refers to the termination of the auction proceedings signalling an end to the price discovery process.

Auction Report

"Service Provider" would provide an Auction Report to the Client containing a summary of the auction proceedings and outcome. The Auction Report would constitute the official communication from "Service Provider" to the client about the outcome of the Auction.

Esteemed Bidders - Please Note: -

- ♣ It is understood by the Buyer that while identifying the offered materials, counting, loading and delivery throughout, representatives from Security and Factory will be monitoring the entire activity to ensure that items loaded onto the Buyer's vehicle are strictly as per the above items in their specific category.
- ♣ The Buyer, prior to giving quotation to the Seller, has already seen, inspected and is satisfied about the condition in which the offered materials is lying in the Seller's premises and Seller will not entertain any return or rejection of the delivered offered materials.
- ♣ The Buyer hereby agrees to clear the offered materials on seller's requirement basis from the premises of the Seller as required.
- ♣ The Buyer hereby agrees to adhere to all the Guidelines issued by the concerned authority from time to time during the course of their activities within the Seller's premises.



- ♣ The Buyer is allowed to enter only in the permitted areas and will arrange his own vehicle, labours, machines, and other equipment as required to remove the offered materials from the Seller's premises.

Note on Auction Process

Auction Methodology: Yankee Auction:

- ♣ There will be a start price and the same will be shown on the bid screen. No bid will be accepted below the start price.
- ♣ The bidders will be able to see their own placed bid rate and quantity.

IN CASE OF ANY CONFLICT OR DIFFERENCES AMONG ANY PROVISIONS OF GTC, BSTC & STC, THE PROVISIONS OF STC WILL SUPERCEDE OTHERS IN THE PARTICULAR E-AUCTION.

THE TERMS & CONDITIONS INCLUDING THE LIST OF MATERIALS APPEARING ON THE DATE OF E-AUCTION IS FINAL AND BINDING ON THE PARTICIPANT BIDDERS. THE SAME MAY PLEASE BE DOWNLOADED FOR ANY FURTHER REFERENCE.

NLCIL INDIA LIMITED Barsingsar, the Owner/Seller, will be hereinafter referred to as PRINCIPAL/NLCIL and MJUNCTION SERVICES Ltd., the Selling Agent of the PRINCIPAL, will be hereinafter referred to as MJUNCTION SERVICES. (1) **Eligibility**:

(2) **Registration:**

2.1 Before participation in the e-Auction, a prospective Buyer shall be required to get itself/ himself registered with MJUNCTION SERVICES appointed by NLCIL for conducting e-Auctions. Registration is to be done online by visiting the Website of MJUNCTION SERVICES Limited viz., www.mjunction.in. Thereafter, bidders will be required to submit documents such as copy of Income Tax return (latest), PAN

(7) **Procedure of Fly Ash Delivery**

- 7.1 NLCIL shall issue Sale / Delivery Orders to the successful bidders in terms of Clause 6.5 after realization of payment. The Buyer has to submit the option before the issue of the Sale/ Delivery Order for movement of the Fly Ash within State or Outside State and the Sale / Delivery Order would indicate the same accordingly. However, the delivery challan/Invoice issued by NLCIL shall indicate the destination.
- 7.2 **The validity period** to complete lifting of Fly Ash by road shall be 3 months from the date of issue of Sale/Delivery Order. Extension of validity will be at the sole discretion of NLCIL based on merits. Fly Ash sold, but not removed within the above specified period will become the property of NLCIL and it has the right to sell the un-lifted quantity in any manner as NLCIL may deem fit without any notice.

The successful bidders shall ensure that they are lifting pro rata quantity of fly ash on daily basis (Pro rata quantity = (Awarded quantity / Validity period).



- 7.3 It is the responsibility of the Purchaser/Buyer/Bidder to take delivery of the Fly Ash from the storing area, strictly adhering to the safety pre-cautions and the provisions of Environment Protection Act. The loading of the Fly Ash and transportation to the bidder's premises shall be the responsibility of the buyer only and they shall not give any room for complaint of pollution, whatsoever. - 7.5 The Fly Ash after confirmation of sale, left at NLC India Limited, will remain at the sole risk and responsibility of the purchaser/bidder/buyer. MJUNCTION SERVICES/NLC India Limited will not undertake any liability, whatsoever for the safe custody, protection or preservation after the sale has been confirmed. Delivery of the fly ash from the silos is subject to mechanical operation. No complaint will be entertained regarding the quality of the materials sold, once the bid is accepted.

(8) Refund of EMD for Unsuccessful bidders:

- 12.10 NLCIL / MJUNCTION SERVICES reserves the right to cancel the sale of Fly Ash under this e-Auctionfrom any source / location in part or whole at any stage at its sole discretion without assigning any reason thereof and no party shall have any right whatsoever to raise any claim in that regard on that count.
- 12.11 NLCIL/MJUNCTION SERVICES reserves their rights to amend/modify and revise the terms and conditions contained herein in full or in part at any point of time and no party shall have any right, whatsoever to raise any claim in that regard on that count.
- 12.12 Sale under each e-Auction shall be an individual, independent, unique and complete transaction.
- 12.13 NLCIL/MJUNCTION SERVICES will not be in any way responsible for failure to deliver the materials due to cause beyond their control such as strike, lockout, cessation of work by labours, shortened hours, act of GOD or other causes or other contingencies whatsoever. In case of such force majeure conditions, the period of delivery shall automatically get extended proportionately. The buyer/bidder/ purchaser shall not be entitled to cancel the contract.

12.14 **CONDUCT DURING DELIVERY**:

Buyer/bidder/purchaser shall solely be responsible for movement and proper behaviour of their deputies, agents, and labourers within NLCIL's premises. If any damage caused to NLCIL's property, the buyer is responsible to make good such damage to the satisfaction of NLCIL, and the decision of NLCIL, in this regard shall be final and binding. **Reselling of fly ash will not be allowed in**



NLCIL premises.

12.15 **STATUTORY AND SAFETY CONDITIONS:**

Before commencement of delivery operations, the buyer shall take group insurance for the workers under his control, which will not only cover fatal accidents, but also injuries, which may or may not result in partial orpermanent disablement.

12.16 **COMPLIANCE WITH LABOUR LAW AND SAFETY RULES:**

During the delivery period, the workers employed by the buyer within the Barsingsar Thermal Power Plant premises will be governed by the Labour Laws and Rules, Factory Act, Provision of EPF Act 1951 and NLCIL's Security and Safety Rules as applicable.

12.17 ACCIDENTS ETC. TO BUYERS' LABOURER: -

NLC India Limited/MJUNCTION SERVICES will not at anypoint of time be responsible for any injuries caused to the workers engaged by thebuyer due to accident within the , Barsingsar Thermal Power Plant the place of work and premises or at bidder/buyer/purchaser will make transport facility to the accident victims to the hospital and give proper arrangement for medical attention and treatment tohis labourers and their representative. The bidder/purchaser/buyer will be solely responsible for any claim arising out of the employment, injuries to labourers in the course of employment under any statute. It is the responsibility of the bidder / buyer / purchaser toprovide necessary safety appliances like hand gloves, helmet, boots etc., to the labours who are engaged for handling of the goods.

- 12.18 During delivery, if any of the labourers are found not wearing the proper safety appliances they will not be permitted to carry out the delivery works and will be sent out of Barsingsar Thermal Power Plant premises. NLCIL reserves its right to stop the delivery work, if it is carried out in an unsafe manner.
- 12.19 The purchaser/bidder/buyer shall bring their own closed trucks for the lifting of the auctioned items and shall make their own arrangement for lifting and clearing the materials under



supervision of authorized official of the NLC India Limited. NLCIL will notprovide any assistance whatsoever. If the purchaser/bidder/buyer wants to use any hired vehicle, the points noted in clause 12.27 have to be followed scrupulously.

- 12.20 The entry passes for the men and vehicles/trucks/bulkers have to be obtained from the GENERAL MANAGER/Barsingsar Thermal Power Plant/NLCIL or his authorized officer.
- 12.21 The buyer shall observe all statutory and safety measures. The suggestions given by the Safety Officer/BTPP/NLCIL shall be scrupulously followed. All the labour engaged by the buyer must wear safety kits like helmet, shoes, safety belts, gloves, etc. wherever applicable without which the entry is prohibited. The buyer has to make his own arrangements for accommodation and canteen facilities for his workers.

12.22 **BLACKLISTING**:

If it is found that the bidder/buyer/purchaser is not following the terms and conditions of payment/delivery or other conditions of the auction and also indulging in any malpractices either himself or by his agents, deputies or observer, such bidder / buyer / purchaser are liable to be blacklisted and appropriate action will be taken as deem fit by NLCIL/MJUNCTION SERVICES.

- 12.23 No interest will be paid to the purchaser/bidder/buyer on the amount paid or deposited byhim and on the amount refundable to him if any.
- 12.24 Fly Ash is sold on "as is where is basis" from silos and as such no guarantee is given as regards quality.
- 12.25 Removal, loading and transportation of Fly Ash will be allowed with the specific permission obtained from NLCIL's officers authorized by GENERAL MANAGER/ Barsingsar Thermal Power Plant/ NLCIL. The safety precautions and procedures shall be followed.



12.26 Loading of fly ash into the trucks will be carried out on all days including on Sundays and other holidays observed by NLCIL on round the clock basis. The buyers have to keep sufficient vehicles, so as to load the fly ash continuously without getting it accumulated in the silos. The purchaser/ bidder/buyer should intimate in writing in advance as to when vehicle will come for taking out the materials. The buyers are required to adhere to their time schedule. The trucks authorized by the officer-in-charge of Fly Ash Sales/ Barsingsar Thermal Power Plant alone will be permitted inside the silo area for loading of the materials. For the entry of vehicles in the loading place, which is covered in the Barsingsar Thermal Power Plant, the statutory obligations like valid driving license, road tax details, brake checkup clearance, etc. shall be submitted to the officer authorized by the GENERAL MANAGER/ Barsingsar Thermal Power Plant /NLCIL and their permission is to be obtained. If the purchaser/bidder/buyer comes without prior written intimation and permission as above, the NLCIL India Limited has got the right to return the vehicle without loading and purchaser / bidder/buyer cannot claim for any loss towards the same. The loaded lorries shall be permitted to move out of the storing area, after weighment and issue of the Delivery Chelan-cum-Gate Pass duly signed by the officer authorized GENERAL MANAGER, Barsingsar Thermal Power Plant, NLCIL.

Delivery will be subject to the running of power plant units and availability of dry fly ash at silos.

The buyer shall ensure totally pollution free transportation from NLCIL premises to utility point. Any liability arising out due to its non-compliance shall be totally borne by the buyer.

The buyer shall ensure to arrange for closed vehicle for loading of dry fly ash. In case of non-availability of closed vehicle in the market, NLCIL shall allow buyer to load the dry fly ash in open vehicle. In case of loading in open vehicle, the buyer shall ensure to arrange to completely cover the dry fly ash after loading in open vehicle.

12.27 Since the Barsingsar Thermal Power Plant is the important Power



generation plant, necessary care shall be taken while loading the fly ash from the silos and while moving **trucks** inside the plant in such a way to avoid **spillage** and pollution to the possible extent.

12.28 **(a)** The weighment of the trucks shall be done at Barsingsar Thermal Power Plant of NLCIL. The delivery Chelan/Invoice and gate pass will be issued from Fly Ash Sales Division of Barsingsar Thermal Power Plant Then only they shall be permitted to go outside and to their destination. The fly ash vehicles, whether empty or loaded shall notply during each shift beginning and at end, so as to avoid road accidents.

The buyer will lift the fly ash from the silos and the same will be weighed at NLCIL Weigh Bridge. The weighment shall be for both gross weight and the tare weight of the trucks to determine the quantity of fly ash loaded in the trucks.

A suitable weigh bridge installed at the exit point of Barsingsar Thermal Power Plant to facilitate weighment of the fly ash that is being off taken from NLCIL and a record to that effect shall be maintained by both parties, which shall be final and binding for both the parties.

- **(b)** The quantity indicated is approximate only, which may vary, based on the generation of the Dry Fly Ash. The buyers should take delivery of the entire allocated Dry Fly Ash, which may vary at the time of lifting. In case, if the actual quantity is found to be excess, it is permitted to take delivery up to 20% of the Sale/Delivery Oder quantity, on receipt of payment to NLCIL directly for the extra quantities taken delivery. In case, the actual quantities are found to be less, with respect to the indicated one, the value of the un-lifted quantity will be refunded by NLCIL, subject to the forfeiture of the Security Deposit as indicated in Clause-9. The payment for the extra quantity dispatched over and above the Sale/Delivery Order quantity may be monitored by the dispatch Division of Dry Fly Ash and payment to be made to the respective Account Centers.
- 12.29 The outer surface of the loaded trucks shall be cleaned properly/water washed before moving to the Weigh Bridge in such a way to avoid any pollution.
- 12.30 The fly ash will be delivered only to the successful



bidder/buyer/purchaser or their authorized representatives against presentation of photo pass issued by MJUNCTION SERVICES. If the successful bidder/ buyer/purchaser desires to authorize a representative or an agent for delivery, in such case the bidder/purchaser/buyer shall produce suitable power of attorney or authorization letter duly attested by a notary public authorizing his representative or agent to lift the materials from NLCIL India Limited premises.

- 12.31 Employees of NLCIL India Limited /MJUNCTION SERVICES are not eligible to participate or to represent on any ones behalf in the e-Auction.
- 12.32 The entire area for this delivery work is under the control of CISF/Security personnel. Thebuyers and their authorized persons movement are restricted strictly within the delivery area only. If they are found roaming in other areas of Barsingsar Thermal Power Plant/NLCIL, severe action will be taken not only against them, but, also on the successful bidders/buyers for trespassing.
- 12.33 NLCIL / MJUNCTION SERVICES will not be liable for any claim and buyer shall keep NLCIL / MJUNCTION SERVICES fully indemnified and harmless against any claim and proceedings of any of their own or against the employees or other.
- 12.34 **TERMINATION/ BREACH OF CONTRACT**: In the event of bidders failure to fulfill any of the contractual obligations including non-lifting the contracted materials under this agreement, MJUNCTION SERVICES/NLCIL's decision in regard to bidders failure being final and binding on the bidder. MJUNCTION SERVICES/NLCIL shall have the full liberty to do any or all of the following:-

Cancel the contract with immediate effect for the materials under the contract not taken delivery by the bidder as on that date, in which case the Pre-Bid EMD/Security Deposit and EMD along with the balance payment (if paid, any), will stand forfeited.

AND / OR

Retain and / or adjust, recover from bidders any amount lying with MJUNCTION SERVICES / Owner to the bidders credit either under this contract or any other which may at any time become payable /



refundable to the bidder either under this contract or any other contract, the amount of losses or damages or claim that might be incurred by MJUNCTION SERVICES/ Owner in selling the materials under contract not taken delivery by the bidder at bidders risk and costs. Even after such recovery / adjustment by MJUNCTION SERVICES / Owner from bidder any amount as mentioned above lying with MJUNCTION SERVICES/Owner, if any further amount is still found payable/refundable by the bidder, the bidder shall pay the same to MJUNCTION SERVICES on demand without any objection or demur.

- 12.35 MJUNCTION SERVICES shall have the right to issue addendum to the e-Auction document to clarify, amend, modify, supplement or delete any of the conditions, clauses or items stated. Addendum so issued shall form part of original invitation to e-Auction.
- 12.36 The bidder shall have no right to issue addendum to e-Auction document to clarify, amend, modify, supplement or delete any of the conditions or items stated therein.

12.37 **Arbitration:**

In the event of any dispute and / or difference arising between the Bidder/purchaser/Buyer and / or their Agent as to the construction, interpretation and / or execution of the contract and / or the respective rights and liabilities of the parties, such disputes and / or differences shall be referred to the Arbitration. The procedures to be followed for such Arbitration is as follows:

12.37.1 If the Bidder is a PSE:

In the event of such dispute or difference, the same shall be referred by either party to the Arbitration of one of the Arbitrators in the Department of Public Enterprises. The Arbitration and Conciliation Act 1996 shall not be applicable to the Arbitration to this clause. The award of the Arbitrator shall be binding on the parties to the dispute provided; however any party aggrieved by such award may make a further reference for setting aside or revision of the award to the Law Secretary, Department of Legal Affairs, Ministry of Law and Justice, Govt. of India. Upon such reference the dispute shall be decided by the Law Secretary or the



Special Secretary/Additional Secretary when so authorized by the Law Secretary whose decisions shall bind the parties finally conclusively. The parties in the dispute will share equally the cost of Arbitration as intimated by the Arbitrator. The procedure to be adopted in the case of arbitration shall be in accordance with the Circulars/Guidelines as may be issued by the GOI from time to time.

- 12.37.2 If the Bidder is Private Contractor [Other domestic Contractors]:
- 12.37.3 The parties agree to use reasonable efforts to resolve all disputes equitably and in good faith. If any dispute between the parties arises it shall in the first instance be referred in writing to the (NLCIL) Corporation who shall endeavor to resolve the dispute amicably and render a decision within 30 days. The period of 30 days shall be reckoned from the date of receipt of the intimation of the dispute by the Corporation. Save as herein under provided, in respect of a dispute so referred, the decision of the Corporation shall be final and binding upon the parties until completion of the contract and shall forthwith be given effect to by both parties.
- 12.37.4 If either party is dissatisfied with the decision rendered by the Corporation or if the Corporation omits or declines to render a decision within the stipulated period of thirty days, then within a further period of thirty days the dissatisfied party may require by a notification that the dispute shall be referred to Arbitration in the manner herein after provided. Such a notification shall be in writing and it shall be duly served on the other party. Failure to invoke the Arbitration within the time stipulated shall debar the party from seeking reference to Arbitration.
- 12.37.5 Except as otherwise provided in this clause, any dispute arising out of or relating to this contract or the breach, termination or the validity thereof, shall be finally settled by Arbitration in accordance with the Arbitration and Conciliation Act 1996. The Arbitration shall be held at Neyveli/Chennai, Tamil Nadu. The Arbitration proceedings shall be conducted and the award shall be rendered in English. The award shall state the reason upon which it is based.
- 12.37.6 There shall be three arbitrators of whom each party shall appoint



- one. The party requesting that the dispute be referred to arbitration shall, within thirty days of the notification in terms of provision as above under Sub Clause 2.2 appoint an Arbitrator as also call upon the other party to appoint an Arbitrator within 30 days. The two Arbitrators so appointed shall within 30 days of the date on which the second of them is appointed agree on the third Arbitrator who shall act as the Presiding Arbitrator of the Tribunal.
- 12.37.7 This agreement and the rights and obligations of the parties, shall remain in full force and effect and shall, if reasonably possible, continue till the passing of the Award.
- 12.37.8 For the purpose of this clause, the terms Dispute shall include a demand or difference of any kind whatsoever, arising out of the contract and respecting the performance, of the contract, whether during the Contract Period including extensions if any, or after completion, and whether before or after Termination, Abandonment or Breach of the Contract [Except as to any matter, the decision of which is specifically otherwise provided for in Contract]
