- Sale is on `AS IS WHERE IS' basis and hence bidders are required to inspect the materials before bidding and they should fully satisfy themselves as to the nature of the materials. No claims / complaints on this account will be entertained at a later date either by mjunction or seller.

Auction Strategy.

Auction will be conducted using auction methodology of English No-Ties Forward Auction.

Proxy Bidding Mechanism:

It is encouraged to use "proxy bidding" feature. This feature enables a bidder to set a bid amount higher than the SBP(start bid price) or prevailing H1 price up to which system will bid on behalf of the bidder in steps of bid increment. The Proxy amount is not known to anybody except the bidder himself.

Proxy bids can be enabled any number of times in the system. In case of a tie, between a normal and proxy bid, system shall declare the proxy bid as the winner.

In case of a tie, between multiple proxy bids, then the proxy bid set earlier will be declared as H1 bidder.

1. Online bidding process:

- i. All the mentioned items/equipment will be auctioned as per the UOM mentioned in the material list.
- ii. Bid Validity: The bids quoted in online auction procedure of mjunction will remain valid for a period of 10 days from the date of Auction. The seller may request further extension in case of any unforeseen and unavoidable situation. Successful Bidder (H1 Bidder) shall be intimated through issuance of Sale Intimation within the Bid Validity Period of Seller's acceptance to the Bid. Unless otherwise stated in Contract, the date of issuance of Sale Intimation (i.e., Sale Intimation Letter Date) shall be the Effective Date of Sale Contract to be signed between the parties as per the terms and conditions mentioned herein. Failure on part of Successful Bidder to sign the Sale Contract within 15 days of Sale Intimation Date may be treated as a material breach of auction / bidding terms and consequences thereon for dis-honouring of Bid shall apply which shall without prejudice to other legal rights of the Seller include forfeiture of Pre-Bid EMD and delisting or debarring of party from future event participation. Seller may further proceed to award the Sale Contract to any other third party without any recourse to the H1 Bidder.
- iii. After approval of the lot, H1 bidder must acknowledge/accept the receipt of sale intimation letter to mjunction within 48 hours from the date of issuance of the letter through e-mail.
- iv. It will be at the sole discretion of the Seller to accept or reject the BID placed in the online auction or cancel the entire bidding process without assigning any reason.

- v. With the submission of bid (s) by the Buyer, it shall be deemed to be understood that the Buyer has inspected the material and has satisfied himself fully about the nature, quantity, quality, other technical specifications, taxesduties and legalities prior to the-auction. No complaint whatsoever on the points referred to above or any other points with regard to material will be entertained after the submission of the bid.
- vi. Reauction of the materials within the Bid Validity period is not permissible till such time the Bid is approved or rejected by the Seller.

Requirements for Participation

- *All the customers will have a unique account number. The unique account number is an alphanumeric code consisting of 13 characters. - d. **Safety Measurement Criteria for Bidders:** Bidder must meet the safety requirements as per the Seller's Safety Terms and Conditions attached herewith.
- e. Requirement to avail Onsite Inspection:

- v. No Inspection of materials will be allowed to the H1 bidder after the auction has been completed.
- vi. Once a slot for inspection is confirmed to the bidder, thereafter no further changes in slot timing will be acceptable.
- vii. A bidder can inspect the material in only 1 slot. A maximum of 4 representatives from the interested company can visit the site for inspection.
- viii. Bidders visiting the site are required to carry the following documents:
 - 1. Government approved Photo identity proof of each visitor.
 - 2. Duly filled, stamped & signed EOI.
- ix. Travel dates / visiting dates should not be raised without confirmation from mjunction through email.

2. Payment Terms:

- Days would mean calendar days.
- After making the e-payment, Buyer needs to intimate the transaction details through email to mjunction/seller for verification and subsequent action.
- In case, the last day of payment happens to be Closed Holiday for seller/mjunction or the Banking Institutions, the next working day will be taken as the day of payment without late payment charge.
- 3. <u>Work Completion Schedule:</u> The entire Work of dismantling & lifting of all segments of the items under disposal under this tender and clearance / leveling of the site shall be completed **no later than 1 months from the Effective Date**.

4. E-auction lot Status/result:

- Confirmation mail will be sent to the H1 Bidder post the completion of the Auction mentioning that the customer is H1 Bidder & the lot confirmation is subject to approval by seller.
- Post getting approval from seller, Sale Order (SO)/ Lot confirmation Letter will be issued to the H1 Bidder with the details of payments & the timeline for giving the payments.

- 5. Upon acceptance of the auction price by the client, a sale contract will be executed by and between the Client and the buyer and thereafter requisite payments to be made by the buyer to the Client as per the terms and conditions of the auction catalogue.
- 6. Both Parties shall thereon mutually agree on a billing break-up schedule reflecting fair allocation of value to each item considering the total contracted sale value. Also, a dismantling sequence / lifting schedule shall be mutually agreed (which shall be generally in line with the dismantling schedule submitted along with the Bid) such that it complies with the overall agreed completion schedule mentioned above. Dismantling / lifting outside the agreed sequence shall not be permitted.
- 7. Against acceptance / signing of the Sales Contract by Buyer and receipt of complete amount towards the 1st instalment of payment, lifting orders / delivery orders will be issued by the Seller for dismantling and lifting activities in accordance with the payment terms above.

8. Taxes and Duties:

- All taxes or other levies charged under the State, Central or local laws as applicable on the date of delivery shall be payable by the purchaser in addition to the sale value and must be deposited along with the balance purchase money as part of the purchase price.
- At the time of lifting/delivery of the material, if there is any change in regard to the rate of GST and any other
 taxes, then the same will be brought to the notice of the buyer/bidder/purchaser and will be charged extra to
 the buyers/bidder/purchaser account.
- If payment against basic cost only is deposited and amount of GST, TCS and late payment fee, if any, etc. is not deposited by the buyer, then the seller/stockholder at its own discretion shall issue relevant site delivery order for reduced quantities after adjusting the GST, TCS and late payment fee, if any, etc.

9. Security of the material:

- i. The security of the material in the Unit from the date of issue of Sale Intimation Letter onwards becomes the responsibility of the Buyer.
- ii. The Client will provide necessary approval to the Buyer to place his own security to safeguard the material in the premises of the Unit at the Buyer's own cost & expenses.

10. Refund

- i. The Pre-Bid EMD of H1-Bidder shall be retained by mjunction services limited and released post successful lifting of the materials from the site & contract is closed. Buyer to submit a request letter for release of Pre-Bid EMD post completion of lifting to the Seller.
- Pre-bid security of all other bidders will be released in the free pool account post completion of eauction event.

9. Penalties:

- 1. Failure on part of Successful Bidder to sign the Sale Contract within 10 days of Sale Intimation Date may be treated as a material breach of auction / bidding terms and consequences thereon for dis-honouring of Bid shall apply which shall without prejudice to other legal rights of the Seller include forfeiture of Pre-Bid EMD and delisting or debarring of party from future event participation.
- 2. The entire Pre-Bid EMD amount will be forfeited if the H1 Buyer fails to deposit remaining Security Deposit amount within the stipulated time.
- 3. The entire Pre-Bid EMD amount will be forfeited if the H1 Buyer fails to deposit total material value amount including all applicable taxes within the stipulated time
- 4. In the event of any default, apart from the above forfeiture clauses, the Bidder's / Buyer's user id will be disabled, and the Bidder's / Buyer's will be blocked from participating in any auction of Seller with immediate effect.

5. If the successful bidder/Buyer who is awarded contract fails to lift the materials in full within the stipulated period, then Seller / mjunction services limited reserves the right to foreclose/cancel the contract, and in such an event, the entire amount available with mjunction services limited / Seller, under any account head, including the CPBG shall be forfeited.
6. If the dismantling & lifting is not completed within the stipulated timeline, overstay rental charges at the rate of 0.5% per week or part thereof shall be payable by the Buyer to the Seller. However, if the Buyer fails to complete the work and clear the site beyond 01 months from the Effective Date, it may be treated as a material breach of contract and Seller shall be within its right to terminate the contract and forfeit the CPBG and the balance money remaining in account for materials not dismantled and/or not lifted and get such work done by other agencies at the risk and cost of the Buyer

10. Insurance:

The H1 buyer shall take an insurance, safeguarding the client from damage to material & manpower. Buyer shall take all necessary insurances of adequate sums to cover all its manpower / material / resources including 3rd party general liability insurance / workmen compensation as may be applicable. In the event of any loss or damages or any accident etc., Buyer shall make all claims directly with the insurer. The differential amount after settlement of claim shall be borne by the Buyer. Seller shall not be held responsible for loss or damage to any material or equipment or to any personnel of the Buyer including but not limited to Disposed Material whether such loss or damage is caused by accident or otherwise.

The Buyer must submit to the Site-in charge of the Seller, a certificate in duplicate, from the Insurance Company, covering each type of insurance, stating that none of the issued policy will be cancelled without the written consent of the Site-incharge. The Buyer shall name the Seller as a co-beneficiary in each policy in addition to itself as the insured entity. Insurance shall be taken from reputed firms only, preferably from government owned insurance companies or from the insurance companies duly approved by the Seller.

Details of the Insurance are mentioned as Annexure IV.

11. Safety Measurement for Hazardous Materials:

The Buyer shall be fully responsible for disposal of any waste / hazardous waste generated / found during the performance of the Works in compliance with the MOEF & CC / Central Pollution Control Board / State Pollution Control Board at its own cost and risk. To ensure disposal of hazardous waste in an environmentally friendly manner, PCB certificate of either the H1 bidder or their partner will be acceptable. Buyers have to obtain permissions from State PCB wherever required before the disposal of the material. Buyers have to submit a detailed plant for disposal of each type of waste in accordance with the law before the start of the work and same shall be approved by Environment Department. After removal of the Disposed Material, reasonable levelling / flattening / cutting off any protrusions etc. shall also be carried out by the Buyer considering the overall safety of the workplace / Site.

The Buyer shall be fully responsible for disposal of any waste / hazardous waste generated / found during the performance of the Works in compliance with the MOEF & CC / Central Pollution Control Board / State Pollution Control Board at its own cost and risk. To ensure disposal of hazardous waste in an environmentally friendly manner, PCB certificate of either the H1 bidder or their partner will be acceptable.

After removal of the Disposed Material, reasonable levelling / flattening / cutting off any protrusions etc. shall also be carried out by Buyer considering the overall safety of the workplace / Site.

The buyer has to share the invoice copy with the Seller of selling Hazardous item to their Hazardous customer.

General Terms & Conditions: -

GENERAL RULES AND REGULATION GOVERNING CONDUCT OF ONLINE AUCTIONS ON THE "SERVICE PROVIDER" PLATFORM

Introduction:

This Online Forward Auction is being conducted for Seller (herein after referred as the 'Client') on the Auction Platform of mjunction services ltd, (herein after referred as 'Service Provider').

The General Rules and Regulations provided herein govern the conduct of online Forward Auctions arranged by "Service provider" on its Auction Platform. These rules cover the roles and responsibilities of the parties in the online Forward Auctions on the Auction Platform.

Acceptance to these General Rules and Regulations governing conduct of online auctions of the client is a pre-requisite for securing participation in the online auctions.

DEFINITION OF KEY TERMS

Auction

Auction refers to a forum where the requirement for one/more items are stated and the participants (customers) are required to bid the price to be selected for supply of the items /materials as requirement.

Auctioneer

The Online Auction service provider, in this case mjunction services limited.

Online Auctions

Online auctions refer to those auctions conducted through the Internet on the auction platform of mjunction services limited with the customers (from one or more locations) simultaneously bidding for the purpose of selection of supplying/buying the items / materials on Auction.

Award at the Auction

In a single winner format, the customer quoting the highest price is normally allotted the item / materials upon being declared as the H1 Bidder.

Client

Client is the individual/business entity who has entered into an agreement with "Service Provider" to conduct such auction. In case of auction, the purpose would be the genuine intent to sell the selected item / materials to the customers desiring to buy these items from the Client.

Customer

Customer is the individual/business entity participating in the auction, intending to buy the items / materials from the Client. To qualify as a customer in the auction, a business entity has to secure client's approval for participation and accept the General Rules and Regulations.

Auction Engine

Auction Engine refers to the software that encapsulates the entire auction environment, processing logic and information flows. "Service Provider" is the sole owner of the auction engine and retains exclusive right over the utilization of the same.

Timings of the Online Bid

All the timings of the Online Bid shall be based on the time indicated by the Server hosting the Auction Engine. It shall be the endeavor of "Service Provider" to ensure that the Server Time reflects as closely as possible the Indian Standard Time (IST) i.e. GST + 0530 hrs. However, in the event of any deviations between the Server Time and the Indian Standard Time, the functioning of the Auction Engine (Launch, operation, and closure) would be guided by the Server Time. Customers are advised to refresh both the windows of the Auction Module to check the exact Server Time (displayed in both the windows).

Start Time

Start time refers to the time of commencement of the online auction. It indicates the commencement of the Price Discovery process through competitive bidding.

Duration of the Auction

It refers to the period of time, the price discovery process is allowed to continue by accepting bids from competing customers. However, the bidding rules may state the conditions when the prespecified duration may be curtailed/extended.

Auto Extension of the Auction Timings

In the event of bids in the last few minutes of the scheduled bid time, the Bid Timings are automatically extended for a specified period from each such bid. Such Auto Extension shall continue until no bids are placed for the specified period (Engine remains inactive for the specified period). The **Inactivity Time for Auto Extension purpose is mentioned in the first page of the catalogue.** "Service Provider" however retains the right to change the same. The Inactivity Time applicable for the particular Online Bid shall be visible to the customers under the Bidding Rules module on the engine.

End of the Auction.

End of the Auction refers to the termination of the auction proceedings indicating an end to the price discovery process.

Auction Report

"Service Provider" would provide an Auction Report to the Client containing a summary of the auction proceedings and outcome. The Auction Report would constitute the official communication from "Service Provider" to the client about the outcome of the Auction.

Role of "Service Provider"

The role of the service provider is outlined below:

- i. "Service Provider" is the agency (operator) primarily providing the service of the Forward auction to the "client".
- ii. Finalization of the auction items in consultation with the client.
- iii. Defining of bidding rules for each auction in consultation with the client.
- iv. Enhancing bidder awareness and comfort with the auction mechanism and bidding rules.
- v. Input of the Auction items and defining the bidding rule in the auction engine.
- vi. Enlarging the customer base by introducing new bidders.
- vii. Collection of Pre-bid EMD, etc. from the willing bidders and forwarding the same to the Client.
- viii. Providing access to the approved bidders to participate in the Auction.
- ix. Summarizing the Auction proceedings and communicate the outcome to the Client.

The responsibility of fulfilment of the contract rests between the bidders and the client and the Responsibility of the "Service Provider" shall be restricted to the extent of the services provided by them.

Role of Bidder

The role of the bidder is outlined below:

- i. The bidder would participate in the auction with the aim of bidding to secure the auctioned item in the auction
- ii. The bidder would be provided access to the Auction through a "User ID" protected by a "Password". The bidder needs to ensure that the "User ID" and "Password" is not revealed to unauthorized persons. Bidders are also requested to change the password allocated to them by the "Service Provider" to keep their confidentiality. However, it would be bidder's sole responsibility to ensure the security and privacy of the same and he/they would not hold the "Client" / "Service Provider" responsible in any manner whatsoever for any misuse of these user IDs and/or Password. Access to the auction mechanism shall be provided to all the approved bidders subsequent to obtaining their written consent to the General Rules & Regulations and the. Payment of Pre- Bid Earnest Money Deposit (EMD) as decided by the client before the start of the Forward auction will be one of the necessary conditions for participating in the auction.
- iii. Bidders hereby confirm that they shall commit to lift the item (being bid for) at the price entered by them in the auction engine and as per the terms and conditions specified herein by the Client. All Prices entered shall be legally binding on the bidders. Bidders are strongly advised to exercise due diligence while placing bids. Failure to honour the bids placed during online bidding shall render the bidders liable for penal actions deemed fit by "Client" / "Service Provider".
- iv. In the event of winning an allotment in the auction mechanism, the bidder shall commit to fulfil outlined obligations under the contract.
- v. The bidders shall bid on the terms specified by the client & place their bid in the auction engine in the manner specified by "Service Provider". The bidders shall not stipulate any conditions on their own unless the terms of the client (the client's terms & conditions) expressly permit such conditions being stipulated by the bidder. Bids entered with conditions attached shall be considered Conditional bids & "service provider" retains the right of rejecting these bids even without intimating the client.

Bidding Rules

The Bidding Rules refer to the information and terms defined specifically for a particular auction. The purpose of the Bidding rules is to provide approved bidders with the information and terms specific to the auction in which they are bidding. This would include:

- i. Any extension of the duration of the auction in the event of bids being received towards the end of the pre-specified duration
- ii. Start Bid Price
- iii. Specified Unit for Bidding
- iv. Price Increments and any reduction in the price increment in the auction in the event of inactivity
- v. Other attributes (informational/non-negotiable in nature)

While it shall be the endeavor of "Service Provider" to specify these rules at the earliest for each online auction, the "Service Provider" shall retain the right to delay the announcement of these biddings rules or modify rules specified earlier at the time of the online bidding. These details would be available to the bidders on the Auction Engine at the time of bidding.

Participation in the auction process presumes complete awareness and understanding of the Bidding rules.

Conduct of The Auction:

Only those bidders who have been approved by mjunction and shared soft copy of the stamped and signed declaration via email along with required Pre -Bid EMD amount and other necessary documents to the "Service Provider" prior to the start of online auction will be given "Login ID" and "PASSWORD" to enable them view and participate in online auction. The Auction shall be conducted on pre-specified date. The Key Terms pertaining to the conduct of Auction such as "START TIME", "DURATION", "END TIME" AND "AUTO EXTENSION FACILITY" shall be specified separately for each Auction. "Service provider" retains the right to cancel or reschedule the auction, with the approval of the concerned representative of the Client, on any of the following reasons:

• The number of confirmed bidders is deemed insufficient to conduct the

auction

- Some of the confirmed bidders are unable to access the module due to infrastructure problems such as sustained power failure or telecommunication breakdown.
- There are no bids, which are equal to or below Start Bid Price.
- Any other reason which in the opinion of "Service Provider" / "Client" requires such action to be initiated.

The duration of auction may also vary from the pre-specified period of time either on account of termination of the auction by "Service Provider" on the advice of the Client.

Or

In case of situations where it is felt that continuance of the auction proceedings is prejudicial to the smooth conduct and / or the integrity of the auction process.

Or

due to Auto Extension during the Auction, duration may increase from specified period.

In the event of any problems being faced in the smooth conduct of the auction, "Service Provider" with the approval of the Concerned Representative of the Client, shall have the right to undertake one or more of the following steps:

- Cancellation/pre mature termination of the auction with/without a subsequent rerun of the auction on a mutually decided date
- Cancellation of a bid
- Locking/deactivate a bidder's account (suspension of operations in the account), etc.

In-case of failure of net connection, bidder will give his best price to the "Service Provider". "Service

Provider" will bid on behalf of the bidder with the minimum increment until the bid price reaches the best

Price offered by the bidder, by proxy bidding mechanism.

The best price communicated by the bidder will have to be authenticated by written confirmation or fax to the "Service Provider" and will be kept confidential between the "Service Provider" and the bidder. Bidder will be bound by the price offered. Price quotation(s) received at any point of time through any mode other than the online auction will not be entertained by mjunction services ltd or the client.

Liability of "Service Provider"
