- No complaints regarding differences in material quality or quantity will be entertained once the Auction is conducted.
- Materials sold would be under “as is where is” basis. Any Picking, sorting, cutting, cleaning, or breaking up of scrap materials will not be permitted.
- Loading and weighing of the goods at designated weighing machine have to be executed in the presence of TATA PROJECTS authorized representatives. In case of any dispute, re-weighing shall be done on another weighing machine at the sole discretion of TATA PROJECTS.
- The authorized personnel of the successful bidder visiting the site for lifting the goods should necessarily carry the authorization letter and the proper photo identity.
- TATA PROJECTS will arrange to issue Tax invoice for the transaction without which the goods shall not be removed from the TATA PROJECTS site.

#### **TATA PROJECTS LIMITED TERMS AND CONDITIONS:**

1. Material available with TATA PROJECTS LIMITED is on “As-is, Where-is” and “No complaint basis”.
2. **Inspection of Materials after the Auction is strictly not allowed.**
3. Bidders are required to quote as per Terms and Conditions stipulated by TATA PROJECTS LIMITED. For details about Terms and Conditions, clarifications, site visit kindly contact mjunction services limited.
4. Materials sold would be under “as is where is” basis and “No Complaints” basis. Any Picking, sorting, cutting, cleaning or breaking up of scrap materials will not be permitted.
5. Loading and weighing of the goods at designated weighing machine have to be executed in the presence of TATA PROJECTS authorized representatives. In case of any dispute, re-weighing shall be done on another weighing machine at the sole discretion of TATA PROJECTS.
6. The authorized personnel of the successful bidder visiting the site for lifting the goods should necessarily carry the authorization letter and the proper photo identity.
7. TATA PROJECTS will arrange to issue Tax invoice for the transaction without which the goods shall not be removed from the TATA PROJECTS site.
8. **Invoices for disposal of materials will be done on Lot wise basis. However, Client may issue single invoice or multiple invoices pertaining to particular lot.**
9. Any details like PAN, Bank A/c etc. and copies of documents required for creation of customer code in TATA

PROJECTS system must be provided by the successful bidder.

#### **10. IMPORTANT NOTE:- COVID 19 Scrap Collection Guidelines at TPL factory premises.**

- Stop the Truck at gate on arrival and instruct to report security office for the purpose.
- No shaking hands or touching each other with known and unknown person.
- Screening the Driver & his helper and loading contract outside workers must undergo infrared thermometer by Security before entry to site.
- Ensure driver & his helpers and scrap loading every worker must wear face mask due to COVID 19 pandemic and other regular PPE while scrap loading operation under his supervisor.
- Scrap contracting agency is responsible to ensure and deploy healthy workers for collection of scrap within our premises.
- Self-declaration form must be filled by his contracting agency of their all the workers coming to site and submitted to store in charge / procurement as part of mandatory requirement. (A form is attached herewith and strictly adhere to).
- All vehicles and machinery entering the premises should be disinfected by spray mandatorily and ensure through your store authority / In charge.
- Medical insurance for workers to be made mandatory subject to requirement.
- Scrap contracting agency shall arrange hand cleansing sanitizers bottle / Dettol soap to each truck driver, helper and their workers for regular use of sanitizer and protect them from outside contact any infection.
- While collection of scrap, supervisor must ensure and keep social distancing amongst them at least 1.0 – 1.5 Mtr and educate them to strictly follow.
- Tobacco, Gutka and Pan Masala and spitting within the premises etc., are strictly prohibited all the time.
- There should be total ban of non-essential persons at sites.

#### **11. Payment Terms:**

**H1 bidder to pay 20% of the material value as Security Deposit (caution money) within 3 working days of issuance of Sale Order. This amount shall be adjusted in the last instalment of payment. Balance amount in 100% advance payment before deploying the vehicle for lifting, unless otherwise agreed by TATA PROJECTS LTD as per the Auction Terms and Conditions.**

**Full payment inclusive of taxes and duties must be made by the bidder within Ten (10) days after issuance of sale order.**

**All payments are to be made in the form of RTGS /NEFT in favor of TATA PROJECTS LTD.**

#### **12. Applicable Taxes & Duties:**

The bids are to be placed exclusive of taxes and duties. ***The winning Customer shall be liable to pay all taxes as would be applicable on the date of dispatch of the material and "TATA PROJECTS LIMITED" would not be liable for taxes in any manner, whatsoever.***



### **13. Obligations related to Lifting of materials/items:**

- 13.1. All goods/material must be lifted within 15 (FIFTEEN) days from the date of issuance of Sale Order. TATA PROJECTS LTD at its discretion may provide any additional grace period to complete the lifting.
- 13.2 TATA PROJECTS LTD shall allow the successful bidder to lift the material only after the receipt of 100% bid amount and applicable taxes etc. of the respective lot to be lifted.
- 13.3. Subject to above 13.2, for lifting of lot /lots (total quantity), successful bidder must report by 9:00 AM and in no event after 04:00 pm on working days in the Office of the salvage stores at TPL. No lifting of the material will be allowed on Sunday or other holiday observed by TPL.
- 13.4. In case the last day of lifting happens to be a holiday observed by TATA PROJECTS LTD the next working g day will be taken as the date of lifting without any ground rent.
- 13.5. Bidders must produce the requisite documents at the time of taking lifting of the material.
- 13.6. All deliveries will commence from 9:00 AM and close at 5:30 PM on all working days.
- 13.7. Weighment will be done within Site at TPL Weighbridge. In case Weighbridge not working/not available, 3rd party weighbridge will be used, at least 2 Weighbridges and the weighment considered will be the higher one.
- 13.8. In case the whole or any part of the goods sold in lot basis remain uncleared or there is delay in lifting the entire goods/materials or part thereof by the bidder, even after the additional grace period granted by TPL, the successful bidder shall have no claim whatsoever on the remaining balance/unlifted goods/material and all amount paid to TPL, including ground rent, if any, shall be forfeited at the expiry of the said additional grace period. TPL shall have the right to dispose of such remaining goods/materials in any manner it likes or sell it to any third party at the risk and cost of the successful bidder. The successful bidder will have no right whatsoever to claim any compensation, loss or damages in this regard from TPL.
- 13.9. Bidders are advised in their own interest to make prior appointment with TPL, before placement of vehicles for taking lifting of the materials within the scheduled date of lifting.
- 13.10. The bidder at his own cost will make his own arrangement for segregation, organizing removal, dismantling loading, transporting and he will not be entitled to claim any facility or assistance or cost on this account from TPL.
- 13.11. The successful bidder shall produce the requisite documents for proper identification of the bidder or its authorized representative at the time of taking lifting of the material. It is therefore the responsibility of the bidder to keep the documents in a safe custody. The person who has lifted the material from TPL, by producing requisite documents if subsequently found to illegal possessor/producer of the documents, TPL., shall in no way be responsible/liable for the same. The successful bidder shall ensure that the vehicles sent for lifting of material shall have valid documents including valid license, PUC, etc.
- 13.12. While taking lifting of the material, TPL holds the sole discretion to direct, the manner/order in which the material can be cleared. No segregation of the items of any lot is allowed inside the TPL's premises.
- 13.13. Bidders are advised to take appointment with TATA PROJECTS LTD., prior to making arrangements of the transport vehicles for lifting of the material within the scheduled period.
- 13.14. The cost of loading, dismantling, lifting and transporting of the material shall be borne by the bidder.
- 13.15. The successful bidder shall appoint a designated supervisor for supervising the loading of material and the said supervisor shall be present at all times during the period of lifting.

13.16. The permissible variation in quantity shall not exceed plus or minus 10 percent of the lot mentioned in the bid or the actual material is available at site, whichever is higher. The material lifted and corresponding weight mentioned & certified in the invoice will be final.

13.17. "Successful buyer shall not be allowed to pick or choose or segregate any particular item out of the lot sold by TPL at the time of delivery of the lot. The buyer shall be bound to lift the entire lot as directed by TPL."

13.18. TPL Site Safety norms like wearing of PPE (Safety Shoe, Helmet etc.,) to be worn by workmen of Scrap Customer. Where cutting of big scrap items at Site is applicable, to be done by Scrap Customer. Site safety norms for gas cutting, lifting, shifting through equipment etc. to be followed by the Scrap Customer workmen.

13.19. Authorized representative/Transporter who come for lifting of scrap material to have the authorization letter or e-mail to receive the scrap and acknowledge the documents for receiving. They also need to have valid identity PAN Card/Aadhar Card/Driving License for identification.

13.20. Successful bidder shall lift the Lot 1 material completely post appropriate payments and then only will be allowed to lift Lot 2 material.

#### **14. Penalty Terms:**

1. In the event of non-submission of SD amount: Forfeit of 100% EMD. Buyer to be debarred from all future auctions of TPL
2. Back out due to market conditions post payments and lifting commencement: Forfeit of 100% EMD + Security Deposit (Caution Money) Forfeiture. Buyer to be debarred from all future auctions of TATA PROJECTS LTD.
3. Other defaulter (incidences of pilferage, any kinds of manipulations etc.): Permanently debarred + EMD Forfeiture + Security Deposit (Caution Money) Forfeiture + Balance ADVANCED forfeited.

#### **15. Jurisdiction:**

Any disputes arising out of this catalogue shall be governed by the laws of the Republic of India and will be subject to exclusive jurisdiction of the courts in Mumbai, India. In the event of any dispute arising out of or in connection with the subject matter of this catalogue, the Parties shall first endeavor to resolve such a dispute amicably within thirty (30) days after one Party has received notification from the other Party regarding such a dispute. Should the Parties fail to do so, then such dispute shall be settled by arbitration as per the procedure established under the Arbitration and Conciliation Act, 1996. The arbitration panel shall consist of three (3) arbitrators and the place of arbitration shall be in Hyderabad, India. The language to be used in the arbitral proceedings shall be English. The arbitration award shall be final and binding on the Parties.

#### **16. General terms & conditions:**

- a) Any dispute on quality of material and bid cancellation shall not be entertained at any point after the auction.
- b) Materials shall be sold on "as is where is basis" and no complaint basis" for all lots.
- c) Lot transfer will not be allowed. Payment and invoicing has to done in the name of the H1 bidder, subject to the prices being approved.
- d) Material purchased should be the only material being lifted from the designated location. TATA PROJECTS LTD has



the right to check any vehicle at any moment of time.

e) If material lifted differs from the material that is purchased by the buyer, and then the buyer/authorized representative will be permanently debarred. Also TATA PROJECTS LTD can take any penal action against the buyer/authorized representative. All the material loaded in the vehicle is to be covered in order to follow the safety Compliance of TATA PROJECTS LTD. If the safety compliance is not followed, then TATA PROJECTS LTD can penalize the buyer/authorized representative as deemed fit.

f) Successful bidder will be responsible for and agrees to indemnify TATA PROJECTS LTD, its affiliates and their officers, Directors and employees against any and all losses, claims, liabilities, obligations and costs arising out of any acts, omissions, negligence or violation of the obligations that are contained herein, all applicable laws and/or all security procedures that are put in place by TATA PROJECTS LTD and amended from time to time at the location of pickup for scrap materials

TATA PROJECTS LTD reserves the right to accept or reject any or all the bids without assigning any reason at any stage. The management reserves the right to withdraw at any stage from the sale after advertising or after issue of sale order/release order/intimation letter of any material with any quantity by numbers or weight at any stage without assigning any reason. Sale value for the material so withdrawn, if any paid by the buyer will be refunded (non-interest bearing). TATA PROJECTS LTD will not be responsible for any damages/loss whatsoever to the purchaser on account of such withdrawal.

- i. Client proposes to conduct the auction for sale of the material as mentioned in TABLE 2.
- ii. In Dynamic Rank Seal bid with SBP Visible Forward Auction will be conducted lotwise.
- iii. Bids shall be placed in INR only. Price to be quoted is basic, ex- location exclusive of taxes and duties.

**5. General Rules and Regulation governing conduct of online Auction on the Service Provider platform**

**Introduction:**

This online forward Auction is being conducted for TATA PROJECTS Limited on the Auction Platform of mjunction services ltd.

The general rules and regulations provided herein govern the conduct of on line forward Auction arranged by Service Provider on its Auction platform. These rules cover the **roles and responsibilities** of the Bidders in the online forward Auctions on the Auction platform.

Bidders are advised to read through the key terms pertaining to the online forward Auction as provided in the Catalogue.

**Role of Service Provider**

The role of the Service Provider is outlined below:

- i. It is the agency (operator) primarily providing the service of the forward auction to the Client.
- ii. Finalization of the auction items in consultation with the Client.
- iii. Defining of Bidding Rules for each auction in consultation with the Client.
- iv. Enhancing Bidder awareness of and comfort with the auction mechanism and Bidding Rules.
- v. Input of the Auction items and defining the bidding rule in the auction engine.
- vi. Providing access to the Bidder(s) to participate in the Auction.
- vii. Conduct or extension of Auction time in consultation with Client.
- viii. Summarizing the Auction proceedings and communicate the outcome to the Client.

The responsibility of fulfilment of the contract rests between the Successful Bidder and the Client and the responsibility of the Service Provider shall be restricted to the extent of the services provided by them.

### **Role of Bidder**

The role of the Bidder is outlined below:

- i. The Bidder would participate in the auction with the aim of bidding to secure the auctioned item in the auction.
- ii. The Bidder would be provided access to the Auction through a User ID protected by a Password. The Bidder needs to ensure that the User ID and Password is not revealed to unauthorized persons. Bidders are also requested to change the password allocated to them by the "Service Provider" to keep their confidentiality. However, it would be Bidder's sole responsibility to ensure the security and privacy of the same and he/they would not hold the Client or Service Provider responsible in any manner whatsoever for any misuse of these user IDs and/or Password. Access to the auction mechanism shall be provided to all the approved Bidders subsequent to obtaining their written consent to the terms and conditions of this Catalogue.
- iii. Bidders are strongly advised to exercise due diligence while placing bids. Failure to honour the bids placed during online bidding shall render the Bidders liable for penal action as deemed fit by Client.
- iv. Successful Bidder shall commit to fulfil terms and conditions under this Catalogue.
- v. The Bidders shall bid based on the terms specified in this Catalogue and place their bid in the Auction Engine in the manner specified by Service Provider. Bidders shall not stipulate any conditions on their own unless the terms of the catalogue expressly permit such conditions being stipulated by the Bidder. Bids entered with conditions attached shall be considered conditional bids & the Client retains the right of rejecting these bids.

### **Bidding Rules:**

The Bidding Rules refer to the information and terms defined specifically for a particular auction. The purpose of the Bidding Rules is to provide approved Bidders with the information and terms specific to the auction in which they are bidding. This would include, but not limited to:

- a) Any extension of the duration of the auction in the event of bids being received towards the end of the pre-specified duration
- b) Start bid price
- c) Price increments and any reduction in the price increment in the Auction in the event of inactivity
- d) Timings of Online Bid
- e) Other attributes (informational/non-negotiable in nature)

**Conduct of the Auction:**

Only those Bidders who have been declared as eligible to participate in the auction by the Liquidator/Client and intimated to the service provider and handed over stamped and manually signed Catalogue governing conduct of online Auction along with and other necessary documents to the Service Provider prior to the start of online auction will be given login ID and password to enable them view and participate in online auction. The Auction shall be conducted on pre-specified date. The key terms pertaining to the conduct of Auction such as Start Time, Duration, End Time and Auto Extension Facility shall be specified separately for each Auction. Service provider retains the right to cancel or reschedule the Auction, with the approval of the Client, on any of the following reasons:

- The number of confirmed Bidders are deemed insufficient to conduct the auction
- Some of the confirmed Bidders are unable to access the module due to infrastructure problems such as sustained power failure or telecommunication breakdown. Decision of the Client will be final and binding on Bidders in this regard.
- There are no bids, which are equal to or below start bid price.
- Any other reason which in the opinion of "Service Provider" or "Client" requires such action to be initiated.

The duration of Auction may also vary from the pre-specified period of time either on account of termination of the Auction by Service Provider on the advice of the Client.

Or

In case of situations where it is felt that continuance of the auction proceedings is prejudicial to the smooth conduct and / or the integrity of the auction process or due to Auto Extension during the Auction, duration may increase from specified period.

In the event of any problems being faced in the smooth conduct of the Auction, Service Provider with the approval of the Client, shall have the right to undertake one or more of the following steps:

- Cancellation/ premature termination of the Auction with/ without a subsequent rerun of the auction on a mutually decided date

**Liability of Service Provider:**

- Any breach of terms and conditions of this Catalogue by any Bidder or the Client in the fulfilment of their obligations under the terms and conditions of this catalogue.
- Any delays in initiating the online Auction or postponement / cancellation of the online auction proceedings due to any problem with the hardware / software / infrastructure facilities or any other shortcomings. However, the Service Provider shall, after consultation with the Client, extend or revise the timelines for conducting the Auction again, if agreed by the Client.

While, reasonable care and diligence will be taken by Service Provider in discharge of its responsibilities such as design of the online bid, communication of bid details and rules, guidance to Client and Bidders in accessing the Auction Engine and placing bids, etc. Bidders shall specifically indemnify Service Provider from all liabilities for any shortcomings on these aspects. It is clearly understood that these activities are undertaken by Service Provider to assist the Bidders in participation but the ultimate responsibility on all these counts lies totally with the Bidders.

### **Right of the Client:**

The Client reserves the right to partially or totally accept or reject any / all bids placed in the online Auction without assigning any reason whatsoever. Client shall not have any liability of any kind in case of delay due to reasons not attributable to either the Bidder or Bidders or Service Provider.

### **Confidentiality Clause:**

Service Provider undertakes to handle any sensitive information provided by the Client or confirmed Bidders for the auctions conducted with utmost trust and confidentiality.

Interested Bidders are advised to read through the key terms pertaining to the online forward Auction as provided here.

### **Definition of Key Terms**

**“Auction”** shall mean Online Auction forum where the sale for one/more lots of an item is stated and the participants (Bidders) are required to bid on an electronic platform up the price to be selected to purchase the requirement.

**"Bidding Rules"** shall have meaning as set forth in this Catalogue.

**"Business Day"** shall mean a day which is not a Sunday, Saturday or any other day declared as a public Holiday by the Central Government

**"Catalogue"** shall have meaning as set forth in this catalogue.

**"Change in Law"** means after the date of this Catalogue (i) the enactment, bringing into effect, adoption, promulgation, amendment, modification or repeal, of any Law in India, or (ii) a change in interpretation of any Law in India by a Competent Court of law, tribunal or Indian Government Instrumentality provided such court of law or Indian Government Instrumentality is the final authority under the Law in India for such interpretation, or (iii) change in any consents, clearances, approvals or licenses available or to be obtained for scope of work envisaged in this Catalogue, other than for default of the Bidder claiming such change, which results in any change in any cost of performing the scope of work as per this Catalogue, but shall not include any change in taxes and duties including Corporate Tax and / or personal Income Tax or any such event to the extent that its effect is the imposition of or a change in any Tax.

**"Client" or "Liquidator"** shall mean TATA PROJECTS LIMITED.

**"Service provider"** shall mean mjunction service private limited.

**"Duration of the Auction"** shall mean the length of time the price discovery process is allowed to continue by accepting bids from competing bidders. The duration of the auction would normally be for a pre-specified period of time. However, the bidding rules may state the conditions when the pre-specified duration may be curtailed/ extended. The conditions include:

- Curtailment of auction duration in the event of no bids for a specified period of time  
(InactivityTime)

Automatic extension in the event of bids being entered towards the end of the scheduled duration to facilitate the other bidders to view and react to the bid.

**"End of the Auction"** shall refer to the termination of the auction proceedings signaling an end to the price discovery process.

**“Preview Time”** shall refers to the period of time that is provided prior to the commencement of bidding. The purpose is also to familiarize participants with the functionality and screens of the auction mechanism. It is not mandatory for "Service Provider" to provide PreviewTime.

**“Rs”** shall mean means the lawful currency of India.

**Start Time:** Start time refers to the time of commencement of the conduct of the online auction. It signals the commencement of the price discovery process through competitive bidding.

**“Site” shall mean** TATA PROJECTS Limited.

**“Supporting Documents”** shall have meaning as set forth in this Catalogue.

**“Successful Bidder” shall mean** H1 Buyer whose price has been accepted by the Client, under the terms of the Auction and/or as per those terms and conditions by TATA PROJECTS LIMITED.

**“Supervisor”** shall have meaning as set forth in this Catalogue.

**Timings of the Online Bid:** All the timings of the Online Bid shall be based on the time indicated by the server hosting the Auction Engine. It shall be the endeavour of Service Provider to ensure that the servertime reflects as closely as possible the Indian Standard Time (IST) i.e. GMT + 0530 hrs. However, in the event of any deviations between the server time and the Indian Standard Time, the functioning of the Auction Engine (launch, operation, and closure) would be guided by the server time. Bidders are advised to refresh both the windows of the Auction Module check the exact server time (displayed in both the Windows).

**“Time Limit”** shall have meaning as set forth in this Catalogue.
