1. Bids are invited for sale of BFG Slag as per following details on “as is where is & no complaint” basis. Material is available for sale to CEMENT MANUFACTURERS (Consumers) and non-consumers (traders)

2. Interested tenders in order to satisfy themselves regarding the quality of materials may inspect the site where the material is lying in the Plant on all working days between 10.00 am to 4.00 pm except Sundays and Holidays with prior permission of DGM (Mktg) or DGM (BF-Opn), BSL. No guarantee/commitment is given by SAIL/BSL with regard to quantity or composition of material, quality and size or its fitness, suitability for any specific purpose and use. No complaint /claim in any manner shall be entertained on the above score since the material offered for sale is on “No complaint & as is where is “basis. Free samples up to 5 Kg may be collected by each bidder against written request by their own arrangement on all working days by themselves or their authorized representative to satisfy themselves regarding quality.

3. The quantity given above is approximate and subject to variation. In case the quantity is found to be less than the quantity indicated no claim shall be entertained but amount proportionate to the quantity not made available will be refunded. SAIL/BSL can award the contract for full quantity or part of the material. Notwithstanding the validity of the sale order the same may be foreclosed without prior notice at the discretion of SAIL/BSL for meeting any exigencies / requirement of JV of SAIL, BSL.

4. Earnest Money Deposit (EMD):

Earnest Money Deposit (EMD) shall be deposited in the form of NEFT / RTGS only drawn on any Scheduled bank, in favour of **M/S mjunction Services Ltd** at any branch of HDFC Bank with CMS facility. 6. Material:

Blast Furnace Granulated Slag from CHSGP of BF # 4 & 5 on "As is where is and no complaint" basis. The area where the material is lying may be one of the areas of active work in connection with production of iron & steel. Under no circumstances any operation / action of the purchaser shall interfere with and/or interrupt the normal operation of the plant. All the safety and security rules and regulations are to be fully complied by the buyers.

7. The Service provider M/s M-junction Services Limited will provide an "user ID" and a "Password" to each individual customer, who will submit required EMD and the documents stated as above, to enable them to participate in the dynamic auctioning process of the items / lots of their choice to be conducted in the Website [<https://auction.metaljunction.com>]. Before actual participation, the customer may obtain necessary help from the Service provider so as to enable him or herself to participate in the Online Auction process without any difficulty.

8. Mode of delivery:

- i) The material shall be dispatched through Rail/Rake or Road from K-10 & K-4 Head End preferably.
- ii) Loading to be arranged by the Buyers themselves.
- iii) Material shall be dispatched to the destination as given by the purchaser subject to the availability of wagon and allotment for movement by the Railways..
- iv) Buyers shall have to make advance payment towards the cost of materials, taxes duties, and freight charges to the desired destination.
- v) If there is any other activity entailing any financial implication, the same has to be reimbursed by the buyer as well as any other charges raised by the Railways on a later date on account of overloading, undercharges etc.
- vi) Necessary liaison with Railways is to be done by buyer for availability of rake.
- vii) Lifting/ Delivery by Road: Buyers shall make arrangement to take delivery of material by their own transport arrangement. The road delivery procedure being followed in the Plant would be strictly applicable and the buyer has to abide by the same.

viii) Loading of material to the Railway wagon, buyer's truck/dumpers will be done under the supervision of the Loading department through his authorized representative.

ix) Buyer has to place trucks / dumpers uniformly throughout the contract as per the stipulated time in a day. No detention charges shall be payable under any circumstances by BSL for trucks / dumpers placed by the buyer but not loaded due to any reason whatsoever.

x) The buyer would lift the material as directed by the concerned department or their authorized representative and no pick and choose will be allowed. The decision of the concerned department will be final for the above purpose.

9. Weighment and Invoicing:

Invoicing shall be done on the weight basis in Metric Tonnes as per RR weight and weighment shall be done at BSL's in motion weighbridge or any other designated weighbridge which shall be final for all purposes.

Freight will be charged extra as recorded in the Railway Receipt issued by the Railways based on the chargeable weight.

Weight recorded in the RR shall be the sole criteria for determining the quantity and value of the material dispatched. SAIL/BSL shall not be responsible for any under loading /shortages in transit / evaporation or dripping of water content etc. after loading / weighment (i.e. RR weight) / dispatch.

10. SAIL FA-I, the general terms and condition of Sale through e-auction from SAIL /BSL shall be applicable for this sale.

11. Bidders may quote for one lot or more as indicated in lot details. Award of Sale shall be the sole discretion of SAIL/BSL.

12. Payment Schedule will be as per SAIL/FA-1.
