The H1 party to ensure clearing of lot within the specified lifting time as stated above. The party would pay 100% of the value in the form of Demand Draft on "THE TATA POWER COMPANY LTD, the SD will be forfeited. The quantity mentioned is only indicative and approximate. Actual quantity available at site in the declared lot shall be cleared

#### Other Terms and Conditions

H1 bidder to deploy adequate manpower, in terms of numbers and skills, for carrying out the job of refilling, stacking and loading. Prior permission shall be taken from TATA POWER to carry on the work beyond normal working hours on Off days /Holidays.

Compliance to statutory requirements: The H1 bidder shall bear the entire responsibility, liability and risk relating to coverage of your work-force under all the applicable statutory requirements & shall strictly follow all the Rules & Regulations mentioned in various Acts. They shall also be solely responsible for payment of all benefits such as Provident Fund, Bonus Retrenchment Compensation, Leave, etc. applicable as per various statutory regulations. The party shall undertake to keep TATA POWER indemnified against any claim, liability or damages, whatsoever, arising from non payments of taxes or duties by you/your sub-contractor, or by way of compensation arising from any accident to any person or property of those in your/your sub-contractor's employment, or to any other persons/properties, whomsoever, during the progress of the contract. TATA POWER shall be entitled to make any payments on your behalf, if necessary, to the your personnel, or to any statutory authority, and recover the amount thereof from the moneys due to you or against Bank Guarantees or even recover the same from you, as a debt.

Safety: H1 bidder shall, for the duration of the job, provide & maintain in good order & condition all the requisite protective apparel & safety equipment for all your workmen & staff engaged for the work, and shall ensure all your workmen & staff use that protective apparel/equipment on job. TATA POWER will have the full right to remove such workmen & staff, who do not follow safety rule or avoid wearing safety apparels.

Security: The H1 bidder shall strictly follow security instruction at premises/site and proper control on movement of your men/ materials, entry of your personnel in company premises shall be with valid entry passes only, issued & approved by Company's security. You shall implement, at your cost, the procedures for entry passes, which have to be revalidated. At the end of the contract all the entry passes shall be deposited by you with Company's Administration Dept. You shall record entry of all incoming materials, at Company's Security Gate, as no materials including those, which are returnable, will be permitted to be removed, if not recorded at the time of entry. All materials shall be taken out of Company premises, against valid Gate passes only.

Workman's Compensation Policy / Contract Labour Act: The party shall be solely liable for any accident or injury or loss of life or damage / suffering to its personnel on any account, including militant / terrorist or similar activity that may happen to any of your personnel engaged in connection with performance of this Contract, including any consequential damages.

House-keeping: The H1 bidder shall undertake to maintain continuously the areas of their work neat and tidy. to areas at the site as designed by TATA POWER, using their own transport arrangements. Should it be felt necessary, at any stage, TATA POWER reserves the right to get required works done by other agencies & back charge the cost to you with overheads.
