**2. Bidding modalities:**

2.1 Price Bid Basis: In Indian rupees as per unit of measurement as given in Material List. Price to be quoted is basic, ex- location and as per the taxes and duties indicated in the material list. Exclusive of excise duty & exclusive of Sales tax and any other statutory levies. .

2.2 Type of Auction: English No ties.

2.3 Bid Validity: Bid shall be valid for six working days from the date of auction.

**3. Taxes & duties:**

3.1 VAT / Sales Tax : : To be charged Extra On Actuals

3.2 Excise Duty : Nil

3.3 TCS : : To be charged Extra On Actuals

3.4 CST: For Interstate sales CST will be 2% against “C” form otherwise full CST will be charged. “C” form is to be deposited with the respective TSPDL Office “(Mr. Chintamani Dash - 09234550337

3.5 Any change in Excise duty, taxes and levies applicable at the time of lifting shall be applicable.

**4. Payment terms & conditions :**

**5. Lifting terms & conditions:**

5.1 DOs will be handed over to authorized representatives only.

5.2 Loading Time: 8 AM to 5 PM

Loading shall be given strictly as per the statutory norms & safety norms of TSPDL. **Party to ensure that the workers engaged by them are covered under ESI/Group Insurance & document should be submitted for applying for gate pass.**

## 6. Penalties:

6.1 In case the buyer default in making payments as per the schedule than his security deposit is liable to be forfeited.

6.2 In case of non- lifting of full lot quantity after making full payment, a penalty equivalent to 20% of the material value for the un-lifted quantity against each lot shall be recovered from the customer.

6.3 Penalty for dishonor of instrument:

- IN CASE OF PAYMENT DISHONoured THE PARTY WILL BE PENALIZED & WILL HAVE TO MAKE A PAYMENT OF 2% OF THE DISHONoured AMOUNT SUBJECT TO MINIMUM OF RUPEES TEN THOUSAND & MAXIMUM OF RUPEES ONE LAKH.
- THE BIDDER WILL BE DEBARRED FOR THREE MONTH.

## 7. Complaints :

Complaints, if any with respect to any transaction shall have to be lodged by the buyer within three calendar months from the date of last invoice. No complaint shall be entertained thereafter, under any circumstances.

## 8. Jurisdiction :

8.1 Any dispute arising out of any contract shall be decided in courts of Kolkata. The courts in Kolkata shall have exclusive jurisdiction to adjudicate upon any such dispute.

## 9. General terms & conditions:

9.1 Any dispute on quality of material and bid cancellation shall not be entertained at any point after the auction.

9.2 Materials shall be sold on "as is where is basis" and :no complaint basis" for all lots.

9.3 Lot transfer will not be allowed. Payment and invoicing has to done in the name of the H1 bidder, subject to the prices being approved.

9.4 Material purchased should be the only material being lifted from the designated location. TSPDL has the right to check any vehicle at any moment of time.

If material lifted differs from the material that is purchased by the buyer, and then the buyer/authorised representative will be permanently debarred. Also TSPDL can take any penal action against the buyer/authorised representative. All the material loaded in the vehicle is to be covered in order to follow the safety Compliance of Tata Steel works. If the safety compliance is not followed then . TSPDL can penalize the buyer/authorised representative as deemed fit.

## 11. Compliance to safety norms

11.1 Authorized persons (of the customer) involved in lifting of the materials will be allowed only with Personal Protective Equipments (PPE) i.e., Safety Shoes, Safety Helmet, Safety Goggles, Fluorescent Jacket and Hand Gloves. No "people movement" shall be allowed at the time of loading/delivery of materials from the yards" TSPDL will not be responsible for any delays arising out of Non- Compliance to the Safety Norms.
